31. In case of delay in supply by the stipulated date, DIRECTOR INCHARGE, SAI N.S.Western Centre, Gandhinagar reserves the right of imposing penalty as deemed fit.
32. Rates quoted must include all taxes & freight charges.
33. Payment will be released after one week of satisfactory supply and receipt of goods, supplied as per supply order.
34. The manufacturer/ supplier should give minimum guarantee of one year in case of Sports Kit & Playing kit and other items for material manufacturing defects, and undertake to replace defective products at no extra cost within a month of the defect being brought to notice of the manufacturer/ supplier.
35.
